- No Stallions are permitted on the property.
- No buggy or wagon riding.
- No roughriding or racing.
- No bathing animals in streams or lakes.
- Permit Holder agrees to provide a negative Coggins test for every horse entering the Property, either in person, on demand, or by email (VMCoutdoors@GMAIL.COM).
- Permit Holder agrees to leave the Property in same condition it was upon entering, removing all trash, paper products, etc.
- No dogs allowed without express permission of Company, and then only on a leash.

**WAIVER OR LIABILITY AND INDEMNIFICATION:** Permit Holder exercises its rights hereunder at its own risk, and Company shall not be liable to Permit Holder for any reason whatsoever as a result of Permit Holder's use of the Property under this Permit. Permit Holder shall indemnify Company for any liability for injuries to persons, property or animals made against the Company with respect to the use of the Property by Permit Holder.
